LIMITED WARRANTY - ALTUGLAS INTERNATINAL DIVISION of Arkema **PLEXIGLAS® MC ACRYLIC SHEET**

LIMITED WARRANTY:

Pursuant to the terms and limitations set forth herein, ALTUGLAS INTERNATINAL warrants that for a period of ten (10) years from the Date of Purchase as set forth below ("Warranty Period"), flat, colorless, smooth PLEXIGLAS® MC Acrylic Sheet manufactured by ALTUGLAS INTERNATINAL will not undergo a loss of light transmission in excess of three percent (3%).

CONDITIONS FOR CLAIMS:

In order to make a claim under this Limited Warranty, Purchaser must return the warranted product, original sales receipt and this Limited Warranty to ALTUGLAS INTERNATINAL or the Dealer/Distributor. All such claims must be received by ALTUGLAS INTERNATINAL or the Dealer/Distributor within the Warranty Period, and within thirty (30) days of Purchaser's knowledge of a potential claim under this Limited Warranty.

EXCLUSIONS AND LIMITATIONS:

This Limited Warranty does not cover any damage or loss (i) caused by harmful chemical action, environmental conditions, dirt, atmospheric deposition, scratches, abrasion, changes in the physical structure of the warranted product or (ii) resulting from fabrication, handling, maintenance, storage, transport, cleaning and/or installation contrary to ALTUGLAS INTERNATINAL recommendations. By way of example but not limitation, all outdoor glazing materials are subject to irreversible depositions of atmospheric elements and can be expected to show signs of hazing eventually. Regular and proper cleaning will significantly reduce, but not eliminate, that process. ALTUGLAS INTERNATINAL will not be liable for any special, consequential or incidental damages which may result from the use or application of the warranted product. ALTUGLAS INTERNATINAL' sole liability for a legitimate claim under this Limited Warranty will be the replacement of the warranted product or, at the option of ALTUGLAS INTERNATINAL, the refund of the original purchase price thereof. In no event will ALTUGLAS INTERNATINAL be liable for an amount greater than the purchase price for the warranted product in question.

EXCEPT FOR WARRANTY OF TITLE, THIS IS THE SOLE WARRANTY APPLICABLE TO PLEXIGLAS MC ACRYLIC SHEET.
