Limited Warranty – Plexiglas® SG+ Clear Impact Acrylic Sheet

LIMITED WARRANTY:

Pursuant to the terms and limitations set forth herein, Altuglas International warrants that for a period of ten (10) years from the Date of Purchase as set forth below (“Warranty Period”), flat, colorless, smooth Plexiglas® SG+ Impact Acrylic Sheet manufactured by Altuglas International will not undergo a change in Yellowness Index greater than five (5) units as a result of outdoor exposure, when tested by Altuglas International, in accordance with the procedures specified in ASTM-D-1003.

CONDITIONS FOR CLAIMS:

In order to make a claim under this Limited Warranty, Purchaser must return the warranted product, original sales receipt, and this Limited Warranty to Altuglas International or the Dealer/Distributor. All such claims must be received by Altuglas International or the Dealer/Distributor within the Warranty Period, and within thirty (30) days of Purchaser’s knowledge of a potential claim under this Limited Warranty.

EXCLUSIONS AND LIMITATIONS:

This Limited Warranty does not cover any damage or loss (i) caused by harmful chemical action, environmental conditions, dirt, atmospheric deposition, scratches, abrasion, changes in the physical structure of the warranted product, or (ii) resulting from fabrication, handling, maintenance, storage, transport, cleaning, and/or installation contrary to Altuglas International recommendations. By way of example, but not limitation, all outdoor glazing materials are subject to irreversible depositions of atmospheric elements and can be expected to show signs of hazing eventually. Regular and proper cleaning will significantly reduce, but not eliminate, that process. Altuglas International will not be liable for any special, consequential, or incidental damages which may result from the use or application of the warranted product. Altuglas International’s sole liability for a legitimate claim under this Limited Warranty will be the replacement of the warranted product or, at the option of Altuglas International, the refund of the original purchase price thereof. In no event will Altuglas International be liable for an amount greater than the purchase price for the warranted product in question.

EXCEPT FOR WARRANTY OF TITLE, THIS IS THE SOLE WARRANTY APPLICABLE TO PLEXIGLAS® SG+ IMPACT ACRYLIC SHEET.
